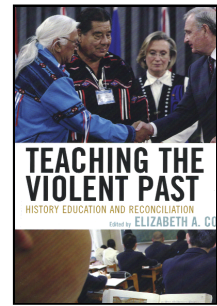

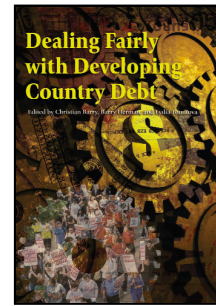

How do you balance obligations to repay a debt with potentially worsening poverty in the debtor country? Should creditors be held accountable—and if so, how—for loans to

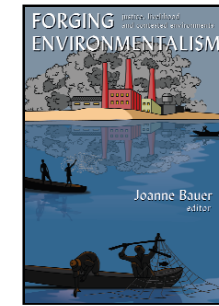
